Every empire needs a currency. Once it was land, then gold, then oil. Today, it is knowledge ; patented, copyrighted, licensed, and locked behind paywalls before it ever reaches the people who need it most.

Imperium Capitalis is not a seminar about intellectual property law in the way law students are used to hearing it as a neutral toolkit for protecting inventors and rewarding creativity. It is an argument that IP has quietly become something else entirely a mechanism of empire. A drug remains too expensive to save lives, not because the science is incomplete, but because a patent says so. An algorithm trained on millions of unpaid, unconsenting creators becomes someone else's billion-dollar asset. A farmer's seed, cultivated over generations, becomes a corporation's exclusive property. The law does not merely record ownership it manufactures it.

Over two days, Government Law College, Kozhikode, through MaFLaC, brings together lawyers, research scholars, economists, technologists, and policy thinkers to sit with an uncomfortable question: when the right to own an idea becomes the right to rule over it, Who really owns knowledge and Who gets left outside the gates?

SUBMISSION GUIDELINES

1. AUTHORS

Paper can be submitted by an Author or with one co-author.(Max. of two authors)

2. ABSTRACT

2.1 Prospective authors must submit an abstract of 250-500 words outlining the research question, methodology, and key arguments of the paper.

2.2 Abstract shall contain 4- 5 keywords.

2.3 Abstract must adhere to 21st edition of Bluebook.

3. FULL RESEARCH PAPER

3.1 Full papers should be between 3,000 to 4,000 words, following academic standards.(Introduction → Research Problem → Research Questions →Objectives → Literature Review → Methodology → Analysis → Findings → Recommendations → Conclusion → References)

3.2 The main text should be in Times New Roman font size 12 and 1.5 line spacing.

3.3 The footnotes should be in Times New Roman font size 10 with single line spacing.

3.4 Full paper must adhere to 21st edition of the Bluebook.

The paper should be the original, unpublished work.

Plagiarized submissions will be disqualified.

4. LANGUAGE

The paper should be written in English.

METHOD OF SUBMISSION

SELECTION PROCESS

1. All abstracts and full papers will undergo a peer -review process by the Paper Review Committee and Academic Committee.
2. Selection will be based on relevance to the themes, originality, and quality of research.
3. Selected papers will be invited for presentation during the seminar, and authors will be notified via email.

DETAILS OF PRESENTATION

Presentation Format (Hybrid mode) : Authors will have 5-7 minutes to present their papers, followed by 3 minutes for question - and - answer session with the audience

PRESENTATION AIDS

1. Projectors and other audiovisual equipment will be available for presenters. Authors are encouraged to prepare visual aids or slides to enhance their presentations.
2. Language: Presentations should be delivered in English.
3. Physical presenters should carry three hard copies.

CALL FOR PAPERS

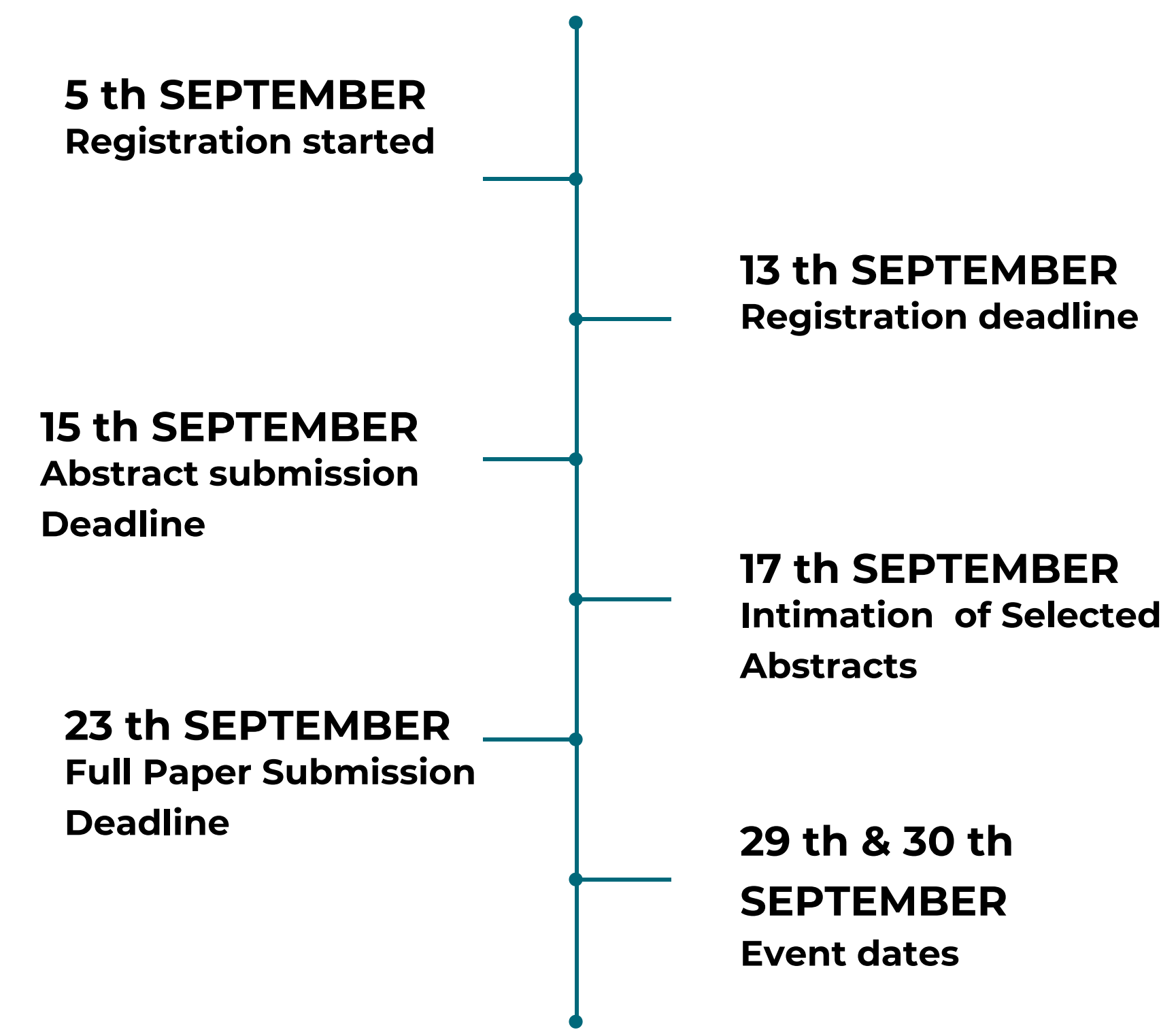

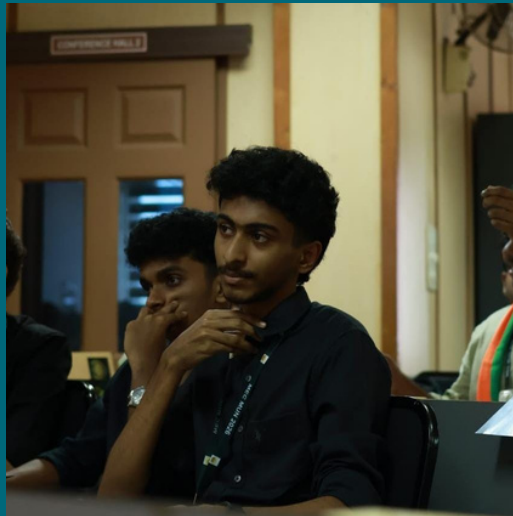
